April Board of Directors Meeting Minutes

Paul Wallace called the Board of Directors' meeting to order on April 9, 2003, at 6:35 P.M. The Board members present were Paul Wallace, Chris Gorsh, and Kathy Morrisson. Mary Rooth, Kirt Shaffer and Suzanne Reeder from Around the Clock, Inc. was unable to attend.

Approve minutes of the Last Meeting

Chris made a motion to approve the March 2003 meeting minutes. Kathy seconded the motion. The motion passed unanimously.

Committee Reports

ACC: Drake Doyle presented the ACC report. The committee members reviewed one requests since the last meeting. The request was approved. The ACC also presented a tree-cutting request for four diseased or dead trees to the Board. The request was approved.

Landscape: Landscape Committee had a meeting March 20th. I introduced my replacement- Kathy Morrison to the committee members. She will be taking over the end of May.

We discussed flowers for the entryways and power lines. We also discussed the possibility of water conservation this summer due to the lack of snow pack we have had this year.

The irrigation systems will be turned on mid-may with the backflow test scheduled at that time. We will not start watering until necessary-probably later on in June or July weather depending of course.

I had a meeting with Ben Nelson of Druids Glenn, Kathy Morrison also attended. We discussed contract item # 3 that states care of the grass area adjacent to 207th entry from Covington-Sawyer rd - Druids Glen agrees to provide care only as follows: repairs and over seeding of damaged areas. Since both sides of the lawn were severely damaged by tire marks with deep ruts, I asked if Druids would over seed and repair the areas according to the signed contract. Mr. Nelson stated that he would not repair these areas, that he didn't read the contract that way. I asked how else it could be interpreted, and stated that there was no expiration date on the signed agreement between Druids and RHOA. He then said that Druids gets a lot of vandalism, a safe was stolen, they are building a clubhouse etc, etc. and Remington gets all of these wonderful perks. i.e. discount golf, use of clubhouse (we haven't had one until now). The point being is that he did not want to repair lawn damage; he was angry with the contract and said it needed to be re-done and that he was going to contact his lawyer. I said fine! He then conceded, and with a verbal yes, said Druids will fix the lawn this time only, we shook hands and adjourned the meeting. He stated that he did not want any problems.

If I have missed any detail then Kathy can fill in. I told Mr. Nelson that since Scott (Dad's) and Clint (his maintenance/ groundskeeper up there) are friends that those two should work out the turf repair as the rocks were going in last Monday. I then gave Mr. Nelson, Dad's Landscaping Phone Number and also Scott's Cell number to give to Clint.

As of last week Scott had tried to contact Druids 3 times to get a time frame for the turf fix, and left messages and has never been called back.

I would like to ask if someone on the Board could contact Druids (Mr. Nelson) as a follow-up and see when they are planning on fixing the turf per Mr. Nelson's verbal agreement.

Chris volunteered to contact Druids Glen regarding the repair of the lawn at the 207th entry.

Social: Janet had several responses of residents wanting to be the Easter Bunny. The Garage Sale will be June 7. She is going to make some new signs. Chris and Paul volun-(Continued on page 3)
