Unidentified vandals destroyed the monument floodlights—along with the protective boxes with mesh wiring that surrounded them. Homeowners who noticed the darkened area were concerned, but the damage was so severe the maintenance committee needed to rebuild all the protective boxes.

We have a continuing problem with destruction of lights at the monuments, not only in terms of replacement (each floodlight is \$85 dollars) but also in terms of one day having to tear down some of the brick structure to be able to fix the damage. The lights inside the monument have been vandalized so many times that eventually we will have to have expensive masonry work done to get to the wiring and fix it.

Thanks go to Dick Smith and Paul Welch for volunteering hours to rebuild the 5 protective boxes and cement them into place—it's because of neighbors like these that the lights are back on!

Also, a homeowner reported seeing 2 teenage girls in the park carving their initials into the newly installed swings. She wasn't sure what they were doing, but saw the damage later. She believes they live in the neighborhood. The swings were less than 24 hours old.

Thinking of Repainting Your Home Or Just Finished Repainting??

Homeowners are repainting their houses without first seeking approval from the Architectural Control Committee (ACC) for color changes. In case you don't know:

- Before painting your house, you must get approval from the ACC. (download the Construction Request Form from the website http://remington.20m.com/forms.htm and then submit it to Richard Green (630-1426) or call Richard and arrange to pick up a form). Then submit the form with paint samples to Richard Green.
- Even if you think the colors are acceptable, you are not exempt from the rules stated in the CC&Rs.
- Everyone needs to abide by the rules in the CC&Rs to protect the investments we have made in our homes.
- It isn't fair to the community for some to follow the rules and others to do what they want with no regard to the rules. It is for your protection (think Pepto-Bismol pink on your next-door neighbor's house!) as well as your neighbor's.
- If you have recently repainted your house without getting approval from the ACC, please submit a Construction Request Form with paint chips for our records.
