July Board of Directors Meeting

The Board of Directors' meeting was called to order on July 8, 2003, at 6:36 PM, with the following members present: Mary Rooth, Kirt Shaffer, Julie Unangst, Paul Welch, and Ronny Wilson. Suzanne Reeder from Around the Clock also attended, along with committee members Roy Crowley, Brian Gilomen, Dick Green, Kathy Morrisson, Mark Rosenberger, Dick Smith, and Janet Smith. A motion was made to approve the May 2003 board meeting minutes and passed unanimously.

Collections/Liens

A recently adopted RHO policy states if any homeowner's association account becomes more than 8 months in arrears, the account shall be referred to a collection agency for collection. A division III lot will be deferred to a collection agency because it is more than 8 months in arrears.

Committee Reports

Architectural Control Committee - Presented by Dick Green

Change Requests. The committee reviewed and approved five requests since the last meeting, which included four house colors and a fence with a waiver. Dick will add a statement to his boiler point stating that the CC&Rs prohibit contractors and homeowners from posting signs to advertise their services. Signs that advertise painting, roofing, and construction company services have been posted throughout Remington in violation of the CC&Rs.

Alternative Roofing. The roofing alternatives listed in the Table 1 were presented to the board:

- An Ever-Shake Shake roof for a 2400 ft2 house would cost around \$13,000. It is unknown what size of roof this quote is for, since there are different roof designs. It is the homeowner's responsibility to investigate cost and increased structural requirements for alternate roofing.
- · A procedure for selecting alternate roofing material was presented:
 - The Homeowner will submit a sample of the proposed material of a color that represents a harmonious match to existing roofs in Remington from the above list along with a Project Request form to the Architectural Control Committee (ACC).
 - The ACC will review the proposed selection and approve or deny the request.
 - The ACC will notify the Homeowner of the outcome with a letter of approval or denial within 30 days of submittal.

A motion was made to give the ACC Committee the authority to approve alternate roofing in accordance with the CC&Rs and passed unanimously.
